6. Business Arising

6.1 COVID-19 Update. Simcoe Muskoka District Health Unit Response and Activities. Verbal Report. C. Gardner and C. Nisbet presenting.

COVID-19 Partner Updates

C. Gardner provided an update of SMDHU's activities to date on the COVID-19 pandemic response noting that worldwide we are nearing 2,000,000 cases and growing. Board members reviewed the situational update and timeline both nationally and locally.

The control and management measures were addressed including vaccines and medications which are currently being trialed clinically, physical distancing, testing, care for cases, and protection for the vulnerable population.

The role of SMDHU was reviewed including case and contact management, public communication, outbreak management, partner engagement and enforcement. The outstanding challenges include workplace IPAC protection for staff, program suspension, costs and the development of a mitigation strategy for harms caused by physical distancing measures.

The projections within Simcoe Muskoka were reviewed and the creation of a new Pandemic Business Continuity Plan was identified along with an operational strategy as this pandemic could continue for up to 2 years.

Board members requested clarification on masks. C. Gardner provided an overview of the different kinds of masks that their application.

Board members discussed essential services and enforcement as well as the issue of people using their seasonal residences. C Gardner noted that this is a plea by the Province and not an order at this time therefore no enforcement is possible.

6.2 COVID-19 Finance Update. Verbal Report. C. Gardner and K. Ellis-Scharfenberg presenting.

K. Ellis-Scharfenberg provided an update of the expenses incurred thus far related to COVID-19 which has demanded an intensive effort from all departments resulting in large financial impacts to salary expenses. There have also been many unbudgeted and unplanned purchases for involving technology, telecommunications, Personal Protective Equipment (PPE – masks, face visors, gowns and gloves to protect from COVID-19 infection) and other supplies directly impacting the SMDHU financial situation.

Board members reviewed the estimated costs of hours worked by staff on COVID-19 activities. Board members requested additional information on staff overtime hours of work and the means to manage and sustain this model. K. Ellis-Scharfenberg provided an update on the call volume and case management work that is occurring.

It was noted that the province has provided announcements to assist with some of these unprecedented costs, however there have been no details communicated at this time. Board members discussed Public Health Modernization and C. Gardner noted that there has been no further communication on this from the Province since the beginning of the pandemic.
