6. Business Arising

6.1 2024 Budget

Briefing Note. Dr. Gardner, Karen Ellis-Scharfenberg, and Jon Van Donkelaar presenting.

K. Ellis-Scharfenberg and J. Van Donkelaar presented the item outlining the Cost-Shared budget, the 2024 COVID-19 Immunization budget, and the 2024 Ontario Seniors' Dental Care Program (OSDCP) for submission to the Ministry of Health. The Ministry of Health announced in 2023 that mitigation funding will become base cost-shared funding rather than an annual one-time funding. Also, the base grant amount would increase by 1% between 2024-2026.

As approved by the Board of Health in September 2023, there will be a contingency reserve draw of \$622,451 to maintain public health services and support for COVID-19 outbreak response for the period January 1-March 31, 2024. Also, the Ministry of Health did state that COVID-19 immunization expenses incurred between January 1-March 31, 2024 would likely be reimbursed.

7.1 External Audit Services Contract Award

Briefing Note. Karen Ellis-Scharfenberg, and Jon Van Donkelaar presenting.

K. Ellis-Scharfenberg and J. Van Donkelaar presented the item providing details on the Request for Proposal (RFP) which was scheduled to be sent out for auditors. Through a deeper investigation, it was determined that two audit companies were listed on the Ontario's Education Collaborative Marketplace (OECM), a strategic sourcing organization established by the

Ontario government to encourage collaborative purchasing across the broader public sector. OECM lists both BDO Canada LLP, our current auditor, as well as KPMG LLP with high ratings, with KPMG LLP, slightly less expensive. Despite the slightly higher costs, it is recommended that BDO Canada LLP be appointed as SMDHU auditors for 2024 and 2025 due to experience with SMDHU many years, BDO's knowledge of our finance systems and continuity of an effective relationship.

Board members discussed future preparedness for extremely high temperatures. Board members were advised that a smoke alert system and cooling centres are in place. Additionally, that the province has provided guidance regarding heat domes and smoke. Much of the learning for smoke and health equity and vulnerable populations comes from British Columbia.
