# COVID-19 Vaccine: Update #13 Appointments Open for 60+ Years, More Essential Caregivers Eligible, and Phase 2 Rollout Continues to Highest and High Risk Health Conditions

**Date:** April 7, 2021

Anyone 60+ years of age (born 1961 or earlier) living in Simcoe Muskoka can now book an appointment to receive their COVID-19 vaccine at a community clinic directly using the provincial booking system.


Clinics in Simcoe Muskoka are now booked until April 17<sup>th</sup>, but appointments from April 18 to May 14<sup>th</sup> have been added. Appointments will continue to be added approximately one month in advance so if appointments book up, people are encouraged to check back.

Alternatively, people 55+ can also access the COVID-19 AstraZeneca vaccine from a <u>local pharmacy</u>. Some primary care providers in our area also have the vaccine available and will reach out to their eligible patients to book an appointment to receive the vaccine. We will have additional AstraZeneca vaccine available for primary care providers in Simcoe Muskoka in the coming days. For primary care providers who have not yet received AstraZeneca vaccine to administer in their practice and are interested in doing so, please refer to our website for more details about how to access vaccine supply.

We are in the third wave of the COVID-19 pandemic and it is a threat in our communities. The quicker people are protected with vaccination, the sooner our communities will be protected, and we can bring the pandemic under control. While there are various vaccines available in various settings, the best vaccine is the vaccine that is available to you first.

# Moving into Phase 2 of the COVID-19 Vaccination Provincial Framework

As we begin to move into Phase 2 of the provincial framework for COVID-19 vaccination, we will be continuing to offer our mass immunization clinics for age-based groups and other groups eligible to register

on SMDHU's website, as well as starting to immunize a number of priority groups in other venues. Immunization of the priority groups listed in the figure below will be done in partnership with hospital and primary care providers, and through mobile immunization clinics. It is important to note that it is expected that this phase will take from now until the end of June to complete, and is dependent on vaccine supply, so we appreciate everyone's ongoing patience as we move through the various groups.

## **Health Conditions**

## **Highest Risk Health Conditions** include the following:

- Organ transplant recipients
- Hematopoietic stem cell transplant recipients
- Neurological diseases in which respiratory function may be compromised (e.g., motor neuron disease, myasthenia gravis, multiple sclerosis)
- Haematological malignancy diagnosed less than 1 year
- Kidney disease eGFR less than 30

### High-Risk Health Conditions include the following:

- Obesity (BMI greater than 40)
- Other treatments causing immunosuppression (e.g., chemotherapy)
- Intellectual or developmental disabilities (e.g., Down Syndrome)

Local hospitals, in collaboration with primary care teams, are currently working to identify and immunize Highest Risk patients followed by chemotherapy patients from the High Risk group, along with eligible essential caregivers (see below). In the coming weeks, any remaining people in the Highest and High Risk

groups and their caregivers will also be added to the eligibility groups for our community clinics, and we will notify you at that time. Patients will be asked to self-attest as belonging to one of the categories, with no documentation required. After those groups are completed, we will open eligibility to the much larger group of At-Risk patients (see the Ministry's <u>Guidance for Prioritization of Phase 2 Populations for COVID-19 Vaccination</u> for the complete list).

# **Additional Essential Caregivers are Now Eligible**

An essential caregiver is someone providing direct, frequent, and sustained in person personal care and/or assistance with activities of daily living to the individual.

The following essential caregivers are now eligible to receive the vaccine. This would typically be administered at the time of the eligible patient/resident:

- For those with Highest Risk Health Conditions up to one essential caregiver
- For those with High Risk Health Conditions up to one primary essential caregiver for those who
  require regular and sustained assistance with personal care and/or activities of daily living
- Essential Caregivers are included for the following congregate settings: developmental services, mental health and addictions congregate settings, homes for special care, children's residential facilities, and Indigenous healing and wellness facilities

# **Hot Spots**

In Simcoe Muskoka, the province has identified the area of Bradford East (with L3Z start to postal code) as a Hot Spot, or priority community, based on ongoing higher rates of COVID-19 transmission, hospitalization, and death. As such, adults age 50 years and over (born in 1971 and earlier) in that community will be eligible to be vaccinated in the coming weeks. Specific opportunities for vaccination will be arranged in collaboration with local health and community partners.
