

### Barrie Supervised Consumption Services (SCS) Site Selection Advisory Committee

# **Terms of Reference**

## I. Purpose

The purpose of the Barrie Supervised Consumption Services (SCS) Site Selection Advisory Committee is to advise and support the Barrie SCS applicants in their development of a successful SCS application, through exploration and review of viable SCS site options in Barrie (Ward 2) and through advising on neighborhood engagement. The area to be explored is the area with the highest concentration of drug use, where it is anticipated that an SCS would be most used. Indicators for a more specific geographic area that will be considered include, but are not limited to: reports from ED visits, outreach services, location of needle exchange sites and the volume of distribution of those sites, and SCS community consultation findings. Sites considered will include all previously explored sites, and new sites not yet explored. If a preferred SCS site location is determined, the Advisory Committee membership will advise/assist the applicants with the neighbourhood engagement and consultation process.

This committee will provide a forum for open communication and exchange of information, discuss potential site options, and fulfill its purpose by being solution-focused and responsive to the needs of people who use drugs and the surrounding community.

The recommendations of the Advisory committee will be strongly considered by the SCS applicants. The final decision on an SCS application rests with the applicants.

#### **II.** Composition and Operations

- A. The Committee will be chaired by the SCS applicants.
- B. The Committee will be composed of key stakeholders with an interest in meeting the goal of a successful SCS application for Ward 2 in Barrie.

- C. The Committee will review guiding principles at the first called meeting to lay the foundation of mutual respect, consideration and sensitivity recognizing the importance of diversity and inclusion. The meetings will not be a forum for debate on the merit of SCS sites or all potential strategies to address the opioid crisis.
- D. The Committee members are encouraged to recognize harm reduction philosophy as the guiding principle of a SCS. Harm Reduction is one component of the response to the opioid crisis, and complements work on prevention, treatment, and enforcement.
- E. The Committee will meet on a bi-weekly basis or at the call of the Chair, until one or more viable sites have been recommended to the applicants, and the neighbourhood engagement and consultation process has been completed.
- F. Minute recording will be provided by one of the SCS applicants. The Committee will establish, based on general agreement, a specific recurring day to meet. The Chair will distribute an agenda prior to the scheduled meetings and minutes will follow post meeting.
- G. Meetings will take place using a virtual platform when meeting in person is not advisable because of physical distancing measures. The meeting location will be at the Health Unit office at 15 Sperling Dr. in Barrie when in person meetings resume with a virtual option being provided for those who cannot attend in person. Members from organizations are requested to send a delegate if they are unable to attend a meeting.
- H. The Committee will strive for consensus in decision making and will make decisions based on a majority of members' views. Opinions/analysis can be shared in person at meetings and on occasion may be accommodated electronically at the discretion of the Chair. Objections will be noted and recorded.
- I. Discussions at the Committee are considered confidential, to support open conversation towards the Committee's purpose. Minutes are not to be shared beyond the committee membership; however, key messages that can be copied and shared broadly will be reflected at the end of the minutes. Monthly written updates will be created and shared with Barrie City Council and the public via the Health Unit SCS webpage.
- J. Timelines for the work of the Committee will be established along with a work plan. It is anticipated site selection and community consultation and engagement will be completed by September 2021.

#### **III.** Duties and Responsibilities

The Committee has the responsibility to:

- A. Determine one or more viable SCS locations that meet the Ministry of Health Consumption and Treatment Services criteria. Committee members may assist in the exploration of potential sites and in recommending alternate SCS site options to the applicants.
- B. Establish ways of appropriately communicating with the neighbourhood surrounding a proposed site and advise/assist with the neighbourhood engagement and consultation process.

#### IV. Accountability

The applicant agencies will make periodic reports to Barrie City Council regarding the work of the Advisory committee and the overall site selection and neighbourhood engagement/consultation process.
