Infection Prevention and Control Requirements for Aerosol-Generating Medical Procedures

Hand Hygiene

Hand hygiene is performed:

- Before and after each patient contact.
- Before performing invasive procedures.
- After care involving body fluids and before moving to another activity.
- Before putting on and after taking off gloves and other PPE.
- After personal body functions (e.g., blowing one's nose).
- Whenever hands come into contact with secretions, excretions, blood and body fluids.
- After contact with items in the patient's environment.
- Whenever there is doubt about the necessity for doing so.

Procedure Room

- All elective aerosol-generating medical procedures (AGMPs) should be postponed until the illness is resolved.
- Whenever possible, perform AGMPs in an Airborne Infection Isolation Room (AIIR) with the door closed. AIIRs should have:
 - a minimum of 12 air changes per hour in new facilities and a minimum of six air changes per hour in existing facilities;
 - inward directional air flow;
 - air exhausted directly outside the building and away from intake ducts 0 or through a high efficiency particulate air (HEPA) filter, if recycled.
 - Keep the number of people in the room during the procedure to a minimum.
 - Have only highly experienced staff perform the procedure.
 - Ensure the door remains closed post-procedure and is not used for another patient until air exchanges have been completed as per your organization's policy and procedures.





Personal Protective Equipment (PPE)

- Wear N95 respirator and eye protection
 - Ensure everyone is instructed in the proper use of N95 respirators and eye protection.
 - Staff should wear a fit-tested, seal-checked N95 respirator and face/eye protection.
- Wear gloves and gown when performing AGMPs.
 - Ensure everyone is instructed in the proper use of gloves and gowns.
 - Wearing gloves is NOT a substitute for hand hygiene.

After the procedure:

- Remove gloves, then gown and perform hand hygiene.
- Remove eye protection, then respirator and perform hand hygiene.



Environment and Equipment

- Ensure the procedure room is cleaned between patients.
- Use equipment and techniques that minimize exposure to respiratory pathogens.
- Thoroughly clean and disinfect reusable equipment between patients as per the manufacturer's instructions for use.



Patient Transport

- Patient to wear a mask during transport, if tolerated.
- If the patient cannot tolerate wearing a mask, transport staff should wear a mask and eye protection.
- Transport staff should consult with IPAC specialist for additional instructions.
- Clean and disinfect equipment used for transportation after use.
