C. Gardner and S. Horney indicated that the Ministry of Health and Long Term Care had communicated its annual grants, and that this was the earliest point in the year that this has ever happened. The cost shared provincial grant includes a 3% increase, which was noted to be most welcomed after the grant freeze of recent years. Because of this, it was noted that the draw from the surplus from previous years may not be required in 2018.

At the June meeting staff will present on the first quarter finances. In addition, at a future Board meeting staff will provide recommendations on the application of unallocated surplus funding regarding the agency's reserve funds.
