Dr. L. Simon and S. Gill shared a presentation with the Board of Health to review the status of engagement with First Nations and Métis Councils.

The Board discussed next steps including the proposals to develop an Indigenous Engagement staff role for 2026 and recruit a provincial appointed Board of Health member from Indigenous communities and/or organizations in Simcoe Muskoka. Following a broad discussion regarding the independent provincial appointment process from that of the Board, and the Board's desire for a breadth of local Indigenous perspectives to

inform next steps, staff were directed to explore the potential for such recruitment for the further consideration of the Board in the future.
