- 6.1 Measles Prevention and Response, Spring 2025. Briefing Note.
  - Dr. C. Lee and D. Thompson presenting.
  - D. Thompson reviewed the contents of this item as follows:
    - SMDHU has been responding to two local cases announced publicly and contacts of measles since March 3, 2025.
    - SMDHU works to limit the spread of measles through its Immunization Program at public clinics and the school program.
    - Surveillance in schools and communication to parents continue annually to keep records up to date.

 The Immunization program has improved efficiencies by utilizing the Can Immunize app (a digital vaccination record) and data sharing agreements.

Dr. C. Lee spoke to the rise of measles cases in Ontario and noted that measles will continue to be relevant due to travel and the current Provincial outbreak.
