- 1) a) Pursuant to Subsection 56 (2) of the Health Protection and Promotion Act, the Board of Health may pass a bylaw on any other matter necessary or advisable for the management of the affairs of the board of health, and:
 - b) Pursuant to Section 49 (4) of the Act, a board of health shall pay remuneration to each member of the board of health on a daily basis and all members shall be paid at the same rate; and,
 - c) Pursuant to Section 49 (5) of the Act, a board of health shall pay the reasonable and actual expenses of each member of the board of health; and
 - d) Pursuant to Section 49 (6) of the Act, the rate of the remuneration paid by a board of health to a member of the board of health shall not exceed the highest rate of remuneration of a member of a standing committee of a municipality within the health unit served by the board of health; and
 - e) Pursuant to Subsection 49 (11) of the Act, subsections 49 (4) and 49 (5) do not authorize payment of remuneration or expenses to a member of a board of health, other than the chair, who is a member of the council of a municipality and is paid annual remuneration or expenses, as the case requires, by the municipality.
- 2) In this by-law:
 - a) "Act" means the Health Protection and Promotion Act; R.S.O. 1990;
 - b) "Board" means the Board of Health for the Simcoe Muskoka District Health Unit.
- 3) The Board of Health for the Simcoe Muskoka District Health Unit enacts as follows:
 - a) That the Chair and each applicable member (District of Muskoka, County of Simcoe, and Provincial appointees) of the Board of Health shall receive a per diem for attendance at the Board of Health Meetings, Committee Meetings and conferences attended as a representative of the Board of Health:
 - b) That the appointees from the Cities of Orillia and Barrie be deemed to receive per diems as per (a) above and that these deemed per diems be refunded at year-end to their respective municipalities.
 - c) That the per diem rate shall be reviewed by the Board of Health in June of the year of a municipal election and set for the upcoming year within the parameters set by the legislation.
 - d) That the per diem rate be adjusted annually in line with approved increases in non-union salary levels provided the rates remain within the parameters set by the legislation.
 - e) That eligible transportation, travel, accommodation and meal expenses be reimbursed according to Health Unit policies and procedures.

By-law 2005-07 read a first, second and third time and finally passed this 20th day of November, 2013.
