Purpose of Position:

The Public Health Inspector (PHI) in the Infectious Diseases Program is an integral team member providing infectious disease and infection prevention and control (IPAC) support to community settings. The PHI may conduct IPAC inspections in childcare and personal service settings which includes providing information, direction and/or enforcement activities to eliminate or ameliorate hazardous conditions or be a facility liaison for institutional settings such as acute care, long-term care and retirement homes. In addition, the PHI will conduct case and contact management of diseases of public health significance including outbreak management. The PHI will further support the program and team members by responding to phone calls on the infectious diseases phone line, providing services upon request to external stakeholders, responding to infection prevention and control complaints. On-call coverage will be optional for this position.

PHIs are statutory officials under the Health Protection and Promotion Act and related regulations. Services provided to the community are defined in the Health Protection and Promotion Act and the Ministry of Health's Ontario Public Health Standards: Requirements for Programs, Services and Accountability.

Responsibilities:

- Actively participate in the delivery of Public Health programs; ensure compliance with regulatory standards & Ontario Public Health Standards related to health protection and promotion, on behalf of the agency.
- Provide public health services based on the principles of health protection, health promotion and disease prevention; offer advice and educational services to encourage community planning and healthy and safe environment; enforce legislation.
- Represent the agency in legal proceedings.
- Contribute to team and agency effectiveness.

Applicants who fail to satisfactorily provide all of the detailed information requested above in their cover letter will be deemed to not meet the minimum job requirements listed in this job posting. Accordingly, their application will not be considered in this competition.

Following submission of your e-mailed cover letter and resume, you will receive a standard reply e-mail confirming your e-mail was received by SMDHU. If you do not receive this confirmation e-mail your electronic application was not received and you will not be considered.
