Responsibilities:

- Work as a member of the Smoke-Free Program within the health unit.
- Develop youth focused health and wellness promotion campaigns related to commercial tobacco and vaping control.
- Develop youth friendly key messages and branding of campaigns that are meaningful to youth.
- Explore best strategies to reach youth with health promotion campaigns.
- Work with Central East Tobacco Control Area Network members to provide advice on the implementation of youth commercial tobacco and vaping prevention campaigns in schools and the community.

- Basic understanding of tobacco use issues and youth;
- General awareness of the health risks associated with tobacco use;
- Intermediate English communication skills verbal and written;
- Strong interpersonal skills and leadership abilities;
