#### **Purpose of Position:**

The Public Health Inspector (PHI) in the Infection Prevention and Control Program is an integral team member providing infection prevention and control (IPAC) support to community settings. The PHI will conduct IPAC inspections in childcare and personal service settings which includes providing information, direction and/or enforcement activities to eliminate or ameliorate hazardous conditions. In addition, the PHI may conduct case and contact management of diseases of public health significance including outbreak management. The PHI will further support the program and team members by responding to phone calls on the phone line, providing services upon request to external stakeholders, responding to infection prevention and control complaints. Oncall coverage will be required for this position.

PHIs are statutory officials under the Health Protection and Promotion Act and related regulations. Services provided to the community are defined in the Health Protection and Promotion Act and the Ministry of Health's Ontario Public Health Standards: Requirements for Programs, Services and Accountability.

#### Responsibilities:

- Actively participate in the delivery of Public Health programs; ensure compliance with regulatory standards & Ontario Public Health Standards related to health protection and promotion, on behalf of the agency;
- Provide public health services based on the principles of health protection, health promotion, disease prevention and education;
- Enforce legislation & represent the agency in legal proceedings; and
- · Contribute to team and agency effectiveness.
