Widespread and Peak Influenza Activity in Simcoe Muskoka

Effective January 16, 2017, the Simcoe Muskoka District Health Unit is declaring widespread influenza activity in Simcoe Muskoka. This widespread activity is likely going to last for 2 to 4 weeks. Widespread activity is defined by Public Health Ontario as "multiple ongoing laboratory-confirmed influenza outbreaks in institutions separated by some geographic distance, in other words, non-adjacent areas". The formal declaration, which includes informing Public Health Ontario of the local situation, serves as a signal to health care partners to enact policies and strategies to control the further spread of influenza.

As of January 13, 2017, there have been 140 lab-confirmed influenza A cases in Simcoe Muskoka since September 1, 2016. In addition to the 33 outbreak-related cases, there have been 107 community lab-confirmed cases. The current proportion of flu tests done that are positive is 22.3%. The influenza A specimens sent for further subtyping have all been H3N2. At this time, the circulating H3N2 appears to be a good match to the vaccine.

Consider timely administration of antivirals (e.g. Oseltamivir (Tamiflu) or Zanamivir) to persons at high risk for influenza complications presenting with influenza symptoms, regardless of immunization status, particularly in the coming weeks when it is expected that influenza activity will increase and peak. Persons who are not immunized with the influenza vaccine, and are working in institutions experiencing confirmed influenza outbreaks, are required to take Oseltamivir (Tamiflu) prophylaxis, 75mg once daily until the outbreak is over if they want to continue to work in the facility.
