Rotavirus Immunization Program – Product Change

Attention: Physicians – Family Practitioners, Nurse and Nurse practitioners, Community Health Centres,

Date: July 26, 2021

The Ministry of Health has announced that Ontario is transitioning from the RotaTeq® (Rota-5) rotavirus vaccine to the Rotarix® (Rota-1) vaccine for the infant rotavirus immunization program, <u>starting August</u> 2021.

- All infants <u>born on or after June 1, 2021</u> (due for their first dose in August at 2 months of age) should be started with Rotarix®.
- Infants <u>born before June 1, 2021 and started their series with RotaTeq®</u> should complete their 3-dose rotavirus immunization series with RotaTeq® vaccine, based on vaccine availability. If RotaTeq® was the vaccine used to start the immunization series and the same vaccine product is not available, complete the series with Rotarix®.

The National Advisory Committee on Immunization (NACI) recommends either vaccine (Rotarix® or RotaTeq®) for protection against rotavirus. NACI does not make a preferential recommendation for one product over the other.

Scenarios to Complete Rotavirus Series

Scenario	Response
1 or 2 doses of RotaTeq® was given and RotaTeq® is available	Complete the 3-dose vaccine series with RotaTeq® at an interval of 4 to 10 weeks between each dose. All doses should be administered by 32 weeks of age.
1 dose of RotaTeq® was given and RotaTeq® is not available	Complete series with 2 doses of Rotarix® at an interval of 4 weeks between doses. Two doses should be completed by < 25 weeks of age.
2 doses of RotaTeq® was given and RotaTeq® is not available	Complete series with 1 dose of Rotarix® by < 25 weeks of age.
If the product is unknown for previous dose(s)	Complete series with 2 doses of Rotarix® vaccine. Note: If any dose in the series was RotaTeq®, a total of 3 doses of rotavirus vaccine should be administered. All doses are required to be administered by < 25 weeks of age.

Both vaccines are available to order using the current vaccine order form on the Health Care Portal of the health unit website at www.smdhu.org/HPPortal. We will do our best to accommodate requests, and once our inventory of RotaTeq® has been depleted, we will fill orders with Rotarix®.
